## INSTRUCTIONS TO VOTER

 Verify that there are initials of an election official at the bottom of the ballot.
 Verify that there are no voting marks on the ballot.
 Use a black ink nep to mark the state. The following are instructions on how to vote your ballot. Please follow these instructions precisely, otherwise, your ballot may not be counted.

1. Verify that there are initials of an election official at the bottom of the ballot.
2. Verify that there are no voting marks on the ballot.
3. Use a black ink pen to mark the ballot.
4. TO VOTE, you must darken the oval completely (♠) next to either "FOR" or "AGAINST".
5. Do NOT cross out or erase. If you make a mistake, write "Void" across the face of the ballot and contact the Seward County Election Commission for instructions at (402)-643-2883.
6. Place voted ballot into the Voter's Official Ballot Return Envelope. Write your NE driver's license or state ID in the space provided on the envelope, or enclose a photocopy of an acceptable photo ID or Reasonable Impediment Certification (if applicable). Complete, SIGN and seal the envelope. Remember to moisten both seals to cover the voter ID and signature boxes.
7. Any person physically unable to sign the envelope must make his/her "mark" and must have an individual witness, Failure to complete and sign the Return Identification Envelope will cause the ballot to be rejected.
8. Do NOT PLACE MORE THAN ONE VOTED BALLOT IN THE Voter's Official Ballot RETURN ENVELOPE.
9. Return Ballot by:

a. Hand Delivery - deliver the ballot to the office of the Seward County Election Commission - 529 Seward St., S b. Mail - return ballot by mail by placing proper return postage on the envelope.
c. Drop Box Location - outside of the Courthouse Building or at the sidewalk level by the street for ballot returns.
10. Ballot MUST be in the possession of the County Clerk's office by 5:00 p.m. Central Time on June 10, 2025.

## SCHOOL BOND ELECTION SEWARD COUNTY SCHOOL DISTRICT 0567 (CENTENNIAL PUBLIC SCHOOLS)

"Shall Seward County School District 0567 (Centennial Public Schools) in the State of Nebraska issue its general obligation bonds in an aggregate stated principal amount not to exceed Seven Million Nine Hundred Thousand Dollars (\$7,900,000), to pay the costs of constructing additions, renovations and improvement to the District's existing school buildings and facilities, including renovations related to kitchen and classroom spaces, construction of a new bus barn, and an auxiliary gym addition, and providing necessary equipment and apparatus for such buildings and facilities; with such bonds to be issued in one or more series, at such time or times, to bear interest at such rate or rates, to be sold at such prices and to become due at such time or times as may be fixed by, or determined at the direction of, the Board of Education; and

"Shall the School District cause to be levied and collected annually a special levy of taxes against all the taxable property in the School District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?"
